


## Training Examples


### Recording a Decision:

- 1) The 'RED' wrestler is always on the left, 'BLUE' on the right.
- 2) Points are awarded as indicated by the referee and separated with a comma.
- 3) The loser's "TOTAL" box contains the total points scored in the period..
- 4) The winner's "TOTAL" box also contains the total period points.
- 5) Note that a Superiority in one period occurred. Because only one period had Superiority, the match is treated as a Decision. A Technical Fall requires 2 periods of Superiority.
- 6) Since the losing wrestler scored at least one technical point, he is awarded one classification point.
- 7) The winner is awarded 3 classification points for a Decision.
- 8) At the conclusion of the match, record the Wall Clock time in the designated box.
- 9) Be sure to 'X' out the loser and verify that the winner's signature matches the winning wrestler's name.

### Recording a Tech Fall: (Superiority)

- 1) The loser's "TOTAL" boxes contain the total points scored in the period. In this case, 0 points.
- 2) The winner's "TOTAL" boxes also contain the total period points.
- 3) Note that superiority occurred in two periods.
  - a. Because two periods had superiority, the bout is treated as a Technical Fall.
  - b. In period one, the Red(Left) Wrestler achieved a six point differential. Signal for the referee to stop the period. Record the elapsed time.
  - c. In period two, Red had a 5 point throw. A 5 point throw (or two - 3 point moves) is automatically a superiority for that period. Signal for the Referee to stop the period. Record the time the move occurred.
- 4) Since the losing wrestler did not score any technical points, he is given "0" classification points.
- 5) The winner is awarded 4 classification points for Technical Superiority.
- 6) Record the Wall Clock time in the lower right hand box when the match concludes.

### Recording a Pin (Fall):



- 10) The loser's "TOTAL" box (period in which the pin occurs) is marked with an "LF". LF means Lost By Fall.
- 11) The winner's "TOTAL" box is **empty**! The elapsed time for this period only is entered in the "TIME" box.
- 12) The winner is awarded 5 Classification Points.
- 13) The loser is given "0" Classification Points regardless of technical points scored.
- 14) At the conclusion of the match, record the Wall Clock time in the designated box.
- 15) Please note that the **LF** in the loser's Total box, the **elapsed Time** in the winner's Time box, the **blank** in the winner's Total box, and the **0** and **5** in the **Classification** Boxes are all required for a fall.

### Recording an Injury Default:



- 21) "INJ" is written in the "TOTAL" box of the wrestler who is injured.
- 22) Write "WBI" in the winner's "TOTAL" box. "WBI" means Won By Injury.
- 23) The winning wrestler is assigned 5 Classification Points.
- 24) The loser is given "0" Classification Points.
- 25) Record the Wall Clock time in the designated box.

## Recording a Disqualification for 3 Cautions:



\* Note that cautions are recorded as '0' technical points.

- 26) "DQ" is written in the "TOTAL" box of the wrestler who is Disqualified.
- 27) Write "WBD" in the winner's "TOTAL" box. "WBD" means Won By Disqualification.
- 28) The winning wrestler is assigned 5 Classification Points.
- 29) The loser is given "0" Classification Points.
- 30) Record the Wall Clock time in the designated box.

### Recording a Disqualification for Misconduct:

- 31) "DQM" is written in the "TOTAL" box of the wrestler who is Disqualified.
- 32) Write "WBD" in the winner's "TOTAL" box. "WBD" means Won By Disqualification.
- 33) The winning wrestler is assigned 5 Classification Points.
- 34) The loser is given "0" Classification Points.
- 35) Record the Wall Clock time in the designated box.
- 36) The referee may want the wrestler eliminated from further competition. If this is the case, circle the "DQM". The referee or designee must hand carry the bout to the head table in this case.

### Recording a Double Disqualification:

- 37) "DDQ" is written in the "TOTAL" box of both wrestlers..
- 38) Both wrestlers are assigned "0" Classification Points.
- 39) Record the Wall Clock time in the designated box.
- 40) The referee may want the wrestler(s) eliminated from further competition. The referee or designee must hand carry the bout to the head table in this case.
